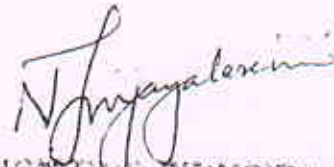

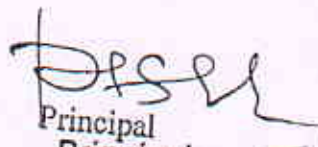

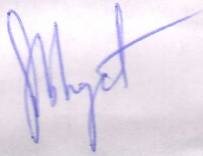
Advantage Vidarbha inaugurated in R.T.M. Nagpur University Campus
